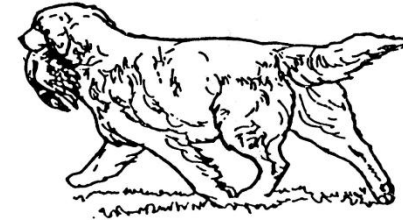

Telegraph, Telephone and Unsigned Entries Cannot be Accepted. Entries Not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Make All Checks and Money Orders payable to **Marshbanks Golden Retriever Club of South-Central Michigan**. Canadian exhibitors must make fees payable in U.S. Funds. Please mail checks or money orders with entries. Trial Secretary assumes no responsibility for cash sent through the mail.

Mail All Entries with Fees to Beth Meade, 1882 Ashley Drive, Ypsilanti, MI 48198. Entries received without fees with not be accepted. Entries sent overnight or express mail or other similar services should be designated **"NO SIGNATURE REQUIRED"**.

Acknowledgement of entries will be made as soon as practical after closing date with judging program and directions to the Trial Site. Should such acknowledgement not be received by the exhibitor within a reasonable time, please contact the Trial Secretary.

A Service Fee of \$1.50 and a Recording Fee of \$0.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test; the Recording Fee for Rally is \$3.00 for each entry of each dog. This Recording Fee is to be collected by the Show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Recording Fee is to be collected for the first entry only. (American Kennel Club Rule, Chapter 11, Section 2).

No entry shall be made and no entry shall be accepted which specifies any conditions to its acceptance.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances or other acts beyond the control of the Club it is impossible to open or to complete the show, no refund of entry fee will be made.

Post-dated and returned checks do not constitute a valid entry fee. The show giving club will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

Errors on entry blanks. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

No practicing will be allowed in the rings at any time. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in judging ring when their classes are called to be judged.

All dogs present must be held on leash or confined to their crates except when being judged or when in the exercising ring.

No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

### LIMITED CRATING AVAILABLE. CRATES MUST BE STACKED UPON REQUEST

Bitches in Season – A refund of all entry fees less \$10.00 will be made to any exhibitor who has a bitch entered who comes in season after the entries close. To be eligible for a refund, a statement from a veterinarian must be presented to the Trial Secretary no later than 9:00 AM the morning of the trial or the veterinarian's statement may be mailed to the Trial Secretary, provided it is received prior to the opening of the trial.

Multiple Entries – When there is a multiple entry of the same dog, only the highest score will be eligible for special awards.

Trophies – All trophies must be claimed at the trial. **NONE WILL BE MAILED.** Any unclaimed awards become the property of the Marshbanks Golden Retriever Club of South-Central Michigan.

Due to space limitations, space for un-entered dogs will not be provided.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
